

## **Camp Agape Privacy Policy**

Effective April 10, 2020

This is the privacy policy (the “**Privacy Policy**”) of this website (the “**Website**”) made available by Camp Agape, a non-profit corporation (“**Camp Agape**”), as well as for the access to and use of any mobile applications supplied by Camp Agape (the “**Applications**”), and access to and use of any services on the Website or Applications (collectively, the “**Services**”). This Privacy Policy describes the information that Camp Agape collects from you as part of the normal operation of the Website, Applications, and Services, as well as how Camp Agape uses and discloses this information.

IMPORTANT NOTE: By accessing or using the Website, Applications or Services, you expressly consent to Camp Agape’s collection, use, and disclosure of your personal information in accordance with the terms and conditions of this Privacy Policy. This Privacy Policy is incorporated into and subject to the Terms of Use for the Website and Services (“**Terms**”), available at [www.CampAgapeTexas.org](http://www.CampAgapeTexas.org). People who visit the Website or use the Applications or Services shall be referred to as “**Users**.”

In this Privacy Policy reference is made to Camp Agape’s “affiliates,” which shall include companies that are affiliated with Camp Agape by reason that these companies are in the same common ownership as Camp Agape. Affiliates shall also include the parent company of the group of which Camp Agape is a member.

### **1. Collection and Use of Information**

This Privacy Policy relates to Camp Agape’s collection and use of any personal information through your use of Camp Agape’s Website, Applications and Services, and any personal information that you provide to Camp Agape, including through email. Camp Agape shall explain in this policy what information Camp Agape collects about you through your use of the Website, Applications and Services, and how Camp Agape uses that information.

Camp Agape may collect basic identifying information from Users, including but not limited to name, email address, and telephone number. For Users create an account, such as via the “Volunteer Application” page of the Website, Camp Agape may collect other identifying information, including login information and password, and postal address. Camp Agape may collect the above information, for example, during the account registration process or through forms you voluntarily submit to us.

Camp Agape may collect information regarding the usage of the Website, Applications and Services, such as a User’s IP address, web browser information, mobile device unique number, mobile software and hardware information, pages or areas visited within the Website, Applications or Services, and what time said pages and areas are visited.

From Users who send e-mail inquiries to Camp Agape or request information from Camp Agape, certain personal information you provide will be used only for the purpose of responding to your inquiry.

Camp Agape may collect information that Users submit to the Website, Applications or Services, such as comments, uploaded media or User Content, contributions to discussions, or messages to other Users.

In addition, Camp Agape may collect information such as name, phone number, email address and desired position from Users applying for a job via the Website. Camp Agape also collects information contained on resumes voluntarily uploaded or sent by job applicants, as well as any information or documentation sent to Camp Agape via email.

Camp Agape may use certain third party payment processors (“**Payment Processors**”) to process personal financial information such as name, phone number, address, postal code, and credit card or bank account information for the purposes of allowing Users to make donations (e.g., via the “Donate Now” page), to register for classes or camps, or to purchase course materials (collectively, the “**Online Purchases**”). This information is provided directly to such Payment Processors by Users, and Camp Agape does not store this information on its servers or computer systems. Namely, all Online Purchases are done through a secure server using GiveDirect or RegPack (and associated third party credit card processing sites and portals), and your credit card information is used only for your intended purpose — for the purchase, donation or contribution you wish to make. Such information is used solely for the purpose of allowing Users to make Online Purchases.

Camp Agape may collect information such as name and email address from Users who sign up for any publications, blogs, or e-newsletters provided to you directly by Camp Agape. Camp Agape also collects other information voluntarily provided by such subscribers to Camp Agape via email or via any sign-up or opt-in pages of the Website. To remove yourself from the mailing list for a Camp Agape e-newsletter, follow the instructions at the bottom of each e-newsletter.

Camp Agape may use your personally identifiable information for activities explained above, for internal and marketing promotional purposes, or when lists of customers’ standard mailing addresses are made available to other non-profit organizations whose products or services might interest Users who have participated in activities on the Website, Applications, or Services, unless you request in writing that Camp Agape not provide such information to these companies. Disclosure of information is explained more fully in the “Disclosure and Sharing of Information” section below.

## **2. Disclosure and Sharing of Information**

The information Camp Agape collects is used to respond to inquiries, improve the content of the Website and Applications, the quality of the Services, fill open positions within Camp Agape’s

organization, facilitate promotions, sweepstakes and contests, and to provide information to Camp Agape and its affiliates for their respective business purposes.

The personal information Camp Agape collects is not sold to or shared with third parties, save and except: (1) as necessary to provide the Website, Applications and Services, or any products or services you request in relation thereto; (2) when Camp Agape has your permission to share your information; (3) it is necessary to share information in order to investigate, prevent or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, or as otherwise required by law; (4) such information is seen by third parties who provide web services or professional services to Camp Agape (including Payment Processors); (5) such information is shared with affiliates of Camp Agape; (6) it is necessary to protect the rights and property of Camp Agape; (7) in the event of a Transfer, as set forth in the “Transfers” section below, (8) in response to request under applicable law (e.g., an order issued by a court of competent jurisdiction, or by a law enforcement agency), (9) when investigating and correcting technical problems and malfunctions in the Website or Applications or the computer systems that support the Website or Applications, or (10) it is necessary to investigate, prevent or take action with regard to a violation of the Website or Terms, or to enforce compliance with the policies governing the Website, Applications and Services (including this Privacy Policy).

Personal information may be available to third parties as noted in the preceding paragraphs and as set forth in the “Collection and Use of Information” section above. Camp Agape makes no representations or warranties about the acts or omissions of such third parties, including whether such parties will keep such information confidential. Camp Agape shall not be liable for any misuse of such information by a third party.

Other than for Camp Agape’s marketing purposes, Camp Agape does not use your email address or other personal information to send commercial or marketing messages without your consent. Camp Agape may use your name, usage history and email address without further consent for non-marketing or administrative purposes (such as notifying you of major updates, customer service needs, or items for which you have requested communication).

### **3. Online Security**

Camp Agape has implemented commercially reasonable technical and organizational measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration or disclosure. However, Camp Agape cannot guarantee that unauthorized third parties will not be able to defeat those measures or use your personal information for improper purposes. You acknowledge that you provide your personal information at your own risk. Camp Agape and its affiliates also assume no responsibility for loss of information, howsoever such information is lost, including information which is permanently deleted either through the actions of an employee or consultant or other who has access to the information, through failures of a computer network, or through any policy or directive of Camp Agape or any of its affiliates for destruction of data. Although Camp Agape takes reasonable measures to ensure the security

of the data you may choose to provide Camp Agape from loss or misuse, unfortunately the transmission of data through the Internet cannot be guaranteed to be 100% secure. Neither Camp Agape, nor its affiliates, nor any of their respective employees, officers or agents or the provider of the internet services on behalf of Camp Agape (nor any other person involving the management or establishment of the Website, Applications or Services) can give any representation or warranty as to the absolute security of the data transmitted using the Website, Applications or Services and cannot give any guarantee that such data will not be compromised by bad actors. If you choose to provide data to or allow collection of data by Camp Agape or any of its affiliates or any of their respective officers, directors or employees, agents, or independent contractors, then you do so understanding the aforementioned risk.

#### **4. Ownership and Storage of Information**

Camp Agape uses third party vendors and hosting partners to provide the necessary hardware, software, networking, storage, and related technology required to run the Website, Applications and Services. Camp Agape and its licensors own the code, databases, and all rights to the Website, Applications and Services, and any feedback you provide, save and except that as between you and Camp Agape, subject to the terms of this Privacy Policy, you retain all rights to the personal information you provide to Camp Agape through the Website, Applications and Services. If you incorporate into feedback any User Content (as defined in the Terms), you hereby grant Camp Agape a worldwide, non-exclusive, royalty-free, sublicensable and transferable license to use, reproduce, distribute, prepare derivative works of, and display the User Content when operating the Website, Applications and Services, and for Camp Agape's internal business purposes. Note that any User Content that you submit to the Website, Applications or Services publicly, you acknowledge that such User Content is publicly accessible. Camp Agape cannot monitor access to public User Content and therefore cannot ensure the privacy or security of such information. Camp Agape is not responsible for the misuse of any public User Content. Camp Agape may also indefinitely store any information that you provide to Camp Agape or any of its affiliates through the Website, Applications, or Services.

#### **5. Transfer of Information**

Customer lists and information are properly considered assets of a business. Accordingly, if Camp Agape merges with another entity or if Camp Agape sells its assets to another entity (collectively referred to as a “**Transfer**”), Camp Agape's contact lists and information, which may include personal information you have provided Camp Agape, would be included among the assets that would be transferred and Camp Agape would request that the entity treat your information in accordance with the Terms (including this Privacy Policy). Camp Agape makes no guarantees as to whether such entity will treat your information in accordance with the Terms (including the Privacy Policy) and disclaims any liability arising out of such entity's failure to do so. This same provision is applicable for each affiliate of Camp Agape.

#### **6. Cookies and Browsers**

A cookie is a piece of data stored on the User's hard drive containing information about the User.

Camp Agape uses cookies, web beacons, log file information and similar mechanisms for all or any of the following purposes:

- To store information so that you will not have to re-enter it during your visit or the next time you visit the Website, Applications or Services.
- To deliver custom, personalized content and information.
- Identify you when you access, visit, or log-in to the Website, Applications or Services.
- To note the different areas of the Website, Applications or Services which have recently been accessed through your computer. Information collected in this way may be used to develop and manage the online services of Camp Agape by, for example, storing information about your preferences so as to enable Camp Agape to customize the Website, Applications or Services according to your individual interests.
- Monitoring the effectiveness of any promotions or marketing campaigns by Camp Agape or its affiliates.
- Tracking your entries, submissions, and status in promotions, sweepstakes, and contests.
- Improving the content of the Website or Applications and conducting various other diagnostics to improve the Services. Camp Agape may, for example, use cookies to monitor aggregate metrics such as total number of User and pages viewed.
- Analyzing and improving the security of the Website, Applications and Services.

The Website, Applications and Services do not respond to “do not track” signals from browsers. Thus, your selection of the “do not track” option provided by your browser may not have any effect on Camp Agape's collection of cookie information for analytic and internal purposes. To effectively manage Camp Agape's collection of cookie information, you may set most browsers to notify you if you receive a cookie, or you may choose to block cookies through the settings associated with your browser. But, please note that if you choose to erase or block cookies, you will need to re-enter your information to gain access to certain parts of the Website, Applications or Services and may not be able to access other parts of the Website, Applications or Services.

Camp Agape may also use Google Analytics to analyze your use of the Website and Services. Google Analytics generates statistical and other information about website use by means of cookies. The information generated relating to Camp Agape's Website is used to create reports about the use of the Website. Google will store and use this information. ## **8. Children's Privacy Policy**

Camp Agape does not knowingly solicit any personal information from children under the age of 13. If Camp Agape is made aware that Camp Agape has collected personal information from a child under 13 years old in a manner that is inconsistent with the Children's Online Privacy Protection Act of the United States, then Camp Agape will delete this information as soon as practicable.

## **9. Links to Other Websites**

The Website, Services and Applications may contain links to other websites that are not maintained or controlled by Camp Agape . Camp Agape is not responsible or liable for the actions of these third parties, including how they process personal information or for the content posted on their websites. Camp Agape is not responsible for the privacy practices (if any) of such other websites, and you are encouraged to review their privacy policies (if any). The fact that a link to a third-party website exists on the Website, Services or Applications does not mean that the third-party site operates under the same or similar privacy practices as set forth in this Camp Agape Privacy Policy. The policies and procedures Camp Agape describes here do not apply to third-party websites. If you decide to use a link on the Website, Services or Applications site to visit another website, Camp Agape encourages you to review the posted privacy policy to learn how any personal information you provide to that site is processed. Your use of a third-party website is at your own risk. You acknowledge that your access of any links to social media features on the Website (e.g., links to Facebook, Instagram, Twitter, etc.) is governed by the terms of use and privacy policies of the companies providing such social media features.

## **10. Public Forums**

The Website, Services and Applications may at certain times make chat rooms, forums, message boards and/or news groups available to you. Please remember that any information that is disclosed in these areas becomes public information. You should therefore exercise caution when deciding to disclose your personal information in these areas.

## **11. Changes to Your Information**

You may change or update information you previously provided to Camp Agape by contacting Camp Agape via e-mail at [director@campagapetexas.org](mailto:director@campagapetexas.org) or via regular mail at PO Box 1484, Marble Falls, TX 78654. Such change may be subject to a fee paid by you to cover Camp Agape's costs.

## **12. Disputes, Questions or Comments**

### **13. Notification of Changes**

Camp Agape reserves the right to revise this Privacy Policy at any time. If Camp Agape makes substantial changes to this Privacy Policy, Camp Agape will endeavor to notify you of such changes (e.g., by email or an alert on the Website for a period of time). However, regularly reviewing this page is the best method to ensure you are always aware of the information Camp Agape collects, how it is used and under what circumstances.
